Message from the Chair

2018 was an eventful year for the Fundy Community Foundation. It was our 25th anniversary. It was the year of self-examination in which we revisited the terms of reference for our committees as well as our strategic plan. It was a year in which our total funds under management grew to almost \$7 million. And it was the year in which five new funds came to the Fundy Community Foundation, including the McGeachy Fund, a restricted fund, in honor of Duncan and Florence McGeachy. Also, among those new funds were a named fund, a donor advised fund and two designated funds from charities that recognise the benefit of having their endowments within the Fundy Community Foundation.

Our gala dinner in November celebrated 25 years of the Fundy Community Foundation and featured guest speaker Andrew Chunilall, CEO of Community Foundations of Canada. Thanks to Bev Tedford for her work in putting that together and to Sharon McGladdery for putting together the silent auction.

Mr. Chunilall spoke of the responsibility and the challenge that community foundations have to embrace to foster diversity in communities while, at the same time, working to break down the divides that can exist within communities and build community. It was a timely message made more so by the subsequent events here in Canada and around the world. The gala was also an opportunity for us to recognise our Founding Chair, Janice Harvey, and our first Executive Director, Inka Milewski for their vision and their work to give the Fundy Community Foundation its start. Without their efforts, the FCF would not be here doing its work today. Likewise, the Community Foundations of Canada, The T. R. Meighen Family Foundation, The Maine Community Foundation and Community Advancement New Brunswick were all critical to our early survival. Indeed, our beginning is a perfect example of what community really is, of how far it can reach and what it can achieve. We are the result of effort that reached across the country and across borders.

The growth in size and complexity of the FCF has necessitated that we invest in new software in order to manage our funds and our granting. To that end, we consulted with other community foundations and our auditor and made a decision to purchase Foundant software, a cloud-based program designed specifically for community foundations. Once it is in place and operating, it will simplify and streamline the workload for our staff. Speaking of staff, we welcomed Catherine Wheeler to the Fundy Community Foundation team this year. She is a welcome addition.

It was over twenty five years ago that I received the call from Inka asking if Karen and I would like to join FCF. Coming back after almost twenty years has been an honor and a challenge. Things change. Processes evolve. Regulators have new requirements. The old dog has to learn new tricks. Many thanks to the board and to our Executive Director, Sandy Thurber, for their tireless effort and for their support. It is truly inspiring to see where the Fundy Community Foundation has come from that beginning with Phoebe Anne Magee's memorial fund honoring her son Brian to the vibrant entity that it is today. We owe a debt of gratitude and an obligation to those like Phoebe and like John Clark and the J. T. Clark Family Foundation, and the many others who have placed, and who continue to place, their trust in us to use their gifts wisely in support of those who are the builders of our community. Together we are doing the things that make our community the welcoming, vibrant, caring, and inclusive place that we all want it to be.



Community Fund Grants Helping Strengthen Communities

\$101,528.00 was awarded to the following projects from the Community Funds and General Funds in 2018:

Spring Grants 2018

Beaver Harbour Community Venture Ltd. – Heating/Cooling Unit for Quaker House: this grant helped provide for the purchase of a heat pump for the community hall, keeping artifacts dry and reducing electrical expenses. \$1000

Blacks Harbour School – Creating Possibilities for Students and Families within Charlotte County: Summer Slide 2018 was an eight-week camp offered to 40 children who improved numeracy and literacy skills over the summer months. The afterschool program Beyond 2:30 featured healthy living, learning opportunities, life skills development and creative expression. \$5000

Dragonfly Centre Inc. – Gross Motor Skills Activities: young adults on the autism spectrum benefited from the purchase of a three-wheeler bicycle and other gross motor skill equipment and games including basketball, bowling and horseshoes. \$980

Grand Manan Museum Inc. – Exhibit Lighting and Signage Interpretation Upgrade: the new displays developed from this project ensure artifacts and photographs are better illuminated with LED lighting. Permanent exhibits in need of renewal for many years received bilingual interpretive signage. \$2000

IODE Heritage Chapter – Literacy for Citizenship: programs at St. Stephen Elementary School, Milltown Elementary School, St. Stephen Middle School, Lawrence Station Elementary School and St. Croix Public Library helped to meet educational needs through books dealing with tolerance, respect, inclusiveness, good citizenship, courage and integrity. \$1000

Nature Trust of New Brunswick – Community Engagement and Stewardship of Bay of Fundy Nature Preserves: this project celebrated the coastal landscapes by encouraging land stewardship and conservation through workshops and the Great Fundy Coastal Clean Up. \$3000

- St. George and Area Food Bank Ride Relief Program: a program designed to help meet community access to the food bank by providing transportation to clients in need. \$800
- **St. Croix Vineyard Inc. & Friends Refugee Medical Assistance:** addressed barriers to education and employment faced by refugees, specifically vision therapy for a twelve year old Syrian girl residing in St. Stephen. \$2500
- St. Stephen's University St. Croix Arts Showcase: highlighting local artists and visual art, a musical component was added to the showcase this year to promote appreciation for the arts. \$800

Van Horne Estate on Ministers Island – Between the Tides Summer Concert Series: over a fourmonth period, this program provided the public and visitors with an intimate experience with leading Canadian musicians, integrating arts, culture, heritage, education and supporting local businesses. \$2000

Town of St. Stephen – Elm Street Park Society: further upgrades of trails and extensive signage throughout the town to promote the park to locals and visitors. Activities included edible wild plant seminars and the St. Stephen Beaver Scouts annual tree planting event. \$1500

- **Vibrant Communities Charlotte County Food Security Focus Groups and Forum:** this successful program contributed to the development of a food security action plan for Southwestern NB and served as a leveraging point for more community support than was anticipated. \$2800
- **St. Andrews Art Council Inc. Music in the Schools:** now in its third year, this educational music program enriches the lives of students from Vincent Massey Elementary School. This year, fifteen xylophones were purchased for use by all grades. \$2500
- **Sunbury Shores Arts & Nature Centre Inc. Making it with Art:** this outreach program to students of St. George Elementary School and St. Stephen High School introduced practicing NB artists Steve Jones and Maggie Higgins who illustrated that pursuing the arts is a culturally valued, viable career path. \$3000
- **St. Croix Estuary Project Inc. Summer Day Camp:** three weeks of specialized camps for children aged 5-12 including several spaces at no charge for children who may otherwise not have had the opportunity to participate. \$1500
- **Boys and Girls Club of Charlotte County Leaders in Training:** targeting youth aged 13-18, this year-round program offers the opportunity to experience team building, enhance communication and leadership skills to prepare teens for the competitive workforce. \$5000
- **Grand Manan Archives Environmental Control Upgrades:** this grant supported the replacement of the electrical panel in the archival storage room to help preserve paper documents. \$1000
- **Rural Community of Campobello Island Fog Fest:** recognizing the area's heritage, culture and natural beauty through music and art while instilling a sense of pride and economic growth in the community. \$3000
- **Town of St. George Main Street Community Garden Project:** transforming a vacant lot into a community garden, encouraging people to engage, learn and connect with others while providing fresh, affordable fruit and vegetables \$2000
- Charlotte County Alternative Transportation Association I'm a Volunteer Recruitment and Recognition: improving the quality of life for the residents of Charlotte County through access to transportation, this project recognized the contributions of volunteers and educated on the impact they have in their communities. \$2500
- **St. Stephen Middle School ASAP: Cooking, Baking and More!:** enhancing the current after school activity program by teaching students important life skills such as working within a budget, meal planning and preparation. \$1600
- **St. Stephen Middle School Access for All:** assisted in providing students with financial assistance for school programs and activities. \$800
- **St. Stephen Middle School Breakfast and Lunch Program:** offering students a nutritious start to their day by providing those in need with breakfast or lunch. \$3000
- **St. Stephen Middle School Digital Art Enrichment:** taking young artists into the 21st century through an afterschool program exploring new painting and drawing technology. \$1220
- **St. Stephen Middle School Ukulele in the Classroom:** this project helped purchase 30 ukuleles to increase music literacy in middle school children with the benefits of improved creativity and self confidence. \$2500

Charlotte County Hospital Foundation – Expand Services in Ambulatory Clinic: to support physician specialists visiting CCH, this program helped to cover the costs of an electrical exam table and three pieces of lifesaving respiratory equipment. \$5000

Fall Grants 2018

Charlotte County Hospital Foundation – Equipment Needs: this project assisted with the purchase of two RIK mattresses, benefitting bedridden patients. \$3000

Blacks Harbour School - Learning Commons Library Upgrades: a three-phased project to modernize the library into a learning commons and media centre for BHS students and families, including new books, furniture and technology. \$2000

The Nature Trust of New Brunswick Inc. – The Great Fundy Coastal Clean-Up: in addition to the Great Fundy Coastal Cleanup in August, cleanups have been held at Nature Trust of New Brunswick preserves located near schools to engage youth in environmental stewardship as well as twenty shoreline cleanups throughout the Bay of Fundy. \$3000

Swallowtail Keepers Society – Improvements to Welcome Centre and Gift Shop: stabilization of the building, transforming its appearance and making it safe for staff and visitors. \$2000

Sunbury Shores Arts & Nature Centre – Making it with Art: in conjunction with the Boys and Girls Club of Charlotte County, free summer art classes for children aged kindergarten to grade five held at Blacks Harbour and Milltown Elementary Schools, where they learned about observing their local environment and their place within it. \$2000

Lakeland Industries Sheltered Workshop Inc. – AED at Lakeland Resource Centre: this grant provided financial assistance to acquire a lifesaving piece of equipment. \$2000

Passamaquoddy Lodge Inc. – Intergenerational Art Program: engaged both residents and children by creating a beneficial intergenerational activity through creative expression, improving the quality of life for residents. \$2000

Grand Manan Museum – Walkway Extension & Gazebo: this project assisted with the purchase and installation of security cameras to monitor the two new exhibits and keep visitors safe. \$1000

Home Support Services Inc. – Meals on Wheels: purchase of upright freezer to allow for the storage of additional inventory. \$700

Charlotte County Ground Search & Rescue – High Visibility Safety Vests for Volunteers: purchase of thirty vests for the team of volunteers, ensuring their safety and that of Charlotte County residents. \$1500

McAdam Historical Restoration Commission – First World War Gallery: creation of a new exhibit honouring CP Railway's commitment to World War I, featuring the original bronze plaque commissioned by the railway in 1922. \$2500

New Brunswick Trails Council Inc. – Simpson Hill Wilderness Trails Project: development of a trail head and construction of safe off-road parking, as well as signage, trail markers and one accessible trail. \$4000

SJDA Student Led Environmental Efficiency Committee – Cold Frame Greenhouse: having outgrown the current greenhouse, the new facility provides a space for teaching the Agriculture 120 Course to students and workshops to community members. \$2000

St. Andrews Art Council Inc. – Gala Festival Concert: a free concert starring the St. Andrews Festival Symphony Orchestra and showcasing emerging artists, enriching the cultural life of Charlotte County. \$2000

St. Andrews Art Council Inc. – Young Artists Showcase: now in its third year, this project increases the self esteem of young people through performing arts and recognizes Charlotte County children of all ages and abilities studying performing arts. \$1000

Town of St. Andrews (St. Andrews Community Players) – Shine a Light: replacement of the outdated lighting in the Arena Theatre with a modern and energy efficient LED system. \$2760

Blacks Harbour School – Skillets and Smiles: provided students with the skills needed to be successful in the kitchen, including the preparation of nutritious meals and snacks. \$2340

Grand Manan Community School Art Department – Clayworks Ventures: students designed and decorated hand-built vessels and sculptures, fostering self esteem, engagement and pride. \$1500

Grand Manan Community School - Yoga Club/Yoga II: this project provided the funds for the purchase of yoga mats, used by students and staff to reset, relax and promote healthy living. \$400

Lawrence Station Elementary School - Sparks Fly Bikes: purchase of three bicycles to promote activity, benefitting both students and staff. \$1400

St. Stephen High, Spartan Art Club - Paint it Forward: Spartan Artists: Provided supplies for the Spartan Art Club to plan and paint artwork in public spaces in St. Stephen. \$700
