Despite restrictions imposed by the continuing pandemic, the Board and staff of the Fundy Community Foundation were still able to get out into the community, and worked hard to improve the quality of life for the people of southwest New Brunswick.

This stunning achievement allowed us to grant \$264,000 in scholarships and grants in 2021, including the support of 33 students and 50 non-profits with projects needed to advance their missions.

CHARLOTTE DIAL-A-RIDE FUND

As John Castell will tell you,

the Dial-A-Ride concept grew from a Fundy Community Foundation led community dialogue back in 2005. The need for accessible local transportation was identified and the organization has not looked back!

Since its inception, Charlotte Dial-A-Ride has provided over 80,000 rides to people in our community who do not have access to safe and reliable transportation. Their model has been duplicated a put to work in many communities across the Atlantic Provinces.

YOUTH LAUNCH

In September of 2020,

Keith Pierce approached the board of Fundy Community Foundation with an inspirational vision: A program dedicated to supporting Charlotte County youth between the ages of 15-29 who are not in employment, education or training. Keith believed that Fundy Community Foundation would be an ideal partner to help him get this program off the ground and address the alarming fact that 20% of youth in Charlotte County are facing significant barriers and subsequently are struggling to move forward in their lives.

Recognizing the need and believing in his vision, the FCF board contracted Keith in November of 2020 to lay the foundation needed to get the program now named *Youth Launch* off the ground. Keith's first task

was finding a charitable community partner to host the program. They were so fortunate to find a home with Neighbourhood Works Inc. (formerly Charlotte County Group Homes) who have been actively engaged in an Community Enhancement Project with their purchase of a church property in St. Stephen. This property will be repurposed in the coming months to become "The Link " - a Community Hub offering transitional housing, a remote learning center, health clinic, and a "one-stop" location where at-risk youth, adults and families in need in our community will be able to access resources, services and programs, including *Youth Launch*.

With his objective clear, Keith's work continues to focus on: (i) building relationships with community partners who will directly or indirectly support the program's objectives and (ii) raising sufficient funds to support the eventual hiring of a Case Manager, an Academic and Essential Workplace Skills Instructor, and a Program Coordinator for Phase 1 (2022-2024) of the program. The goal in Phase 1 will be to support and serve 85-100 at-risk youth in overcoming barriers to education and employment and successfully transitioning to adulthood in order to live lives of dignity and contribute positively to their community. Attaining this goal will have a significant impact on the economic and social wellbeing of Charlotte County.



Philanthropy through the Fundy Community Foundation

Community Funds: The needs of our community are continually changing and in order to respond effectively to grant applications, or pressing community needs, the Foundation encourages gifts that are, at least in part, "undesignated" and can be applied to a "community" fund. This allows the Foundation's Grants Committee discretion to support community projects that may emerge as priorities or be identified by charitable agencies.

Field of Interest Funds: These funds work much like the Community Fund, except that the donors identify a target area of interest that they would like to support (eg. environment, youth, relief of poverty, arts and culture, education, etc). The donor empowers the Foundation to select worthwhile projects to support within these guidelines.

Designated Funds: By establishing a designated fund, donors have the opportunity to specify a particular charity or charities to support in perpetuity. A designated fund may also be created by a registered charity.

Donor-Advised Funds: Donor-advised funds enable a donor to have ongoing participation in the selection of charities that will benefit from their gift. Donors may prefer this type of fund instead of creating a family trust or private foundation.

Scholarships: Some donors wish to endow a scholarship or bursary which relies on the academic institution to recommend the beneficiary each year.

Sustainability Fund: Many donors understand that one of the best ways to help the Foundation achieve its mission is by helping to defray the costs of running the Fundy Community Foundation on a day to day basis. Grants from these funds are used to support the general operations of the Foundation.
