The Fundy Community Foundation Community Grants are awarded annually to charitable organizations and other qualified donees to support programs, projects, or initiatives in rural southwestern New Brunswick. All applications are submitted online through the Foundation's "Online Portal". Grants are typically between **\$1,000 - \$7,500**. This applicant guide contains all the information that applicants will need to prepare and submit their requests to the Foundation. 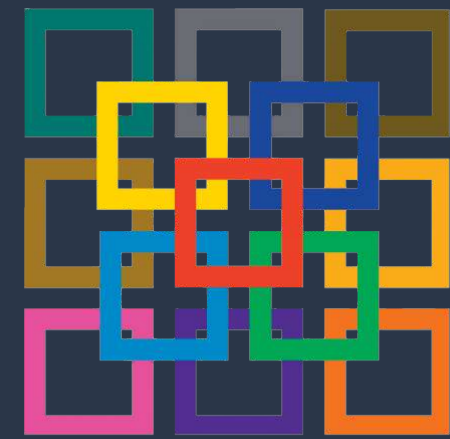
About Fundy Community Foundation

What areas are eligible to receive funding?

Fundy Community Foundation will consider funding requests from qualified donees throughout Charlotte County and rural southwestern New Brunswick. Specifically, the Foundation will consider requests from organizations whose programming takes place in one of the following areas:

- Back Bay
- Beaver Harbour
- Blacks Harbour
- Fundy Isles
- Lawrence Station
- Lepreau
- McAdam
- St. Andrews
- St. George
- St. Stephen/Milltown
- Pennfield

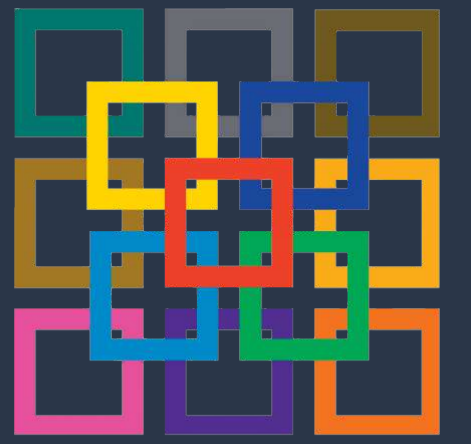
If you are unsure of whether your area is eligible, please contact us.

There are six community foundations throughout New Brunswick. Your organization is encouraged to apply to the Community Foundation in closest proximity to the activities of your project. If your program is province wide, organizations should submit requests to each of the Foundations. The community foundations in New Brunswick are:

Who can apply for a grant?

The following types of organizations are eligible for a grant from Fundy Community Foundation:

- Registered Canadian charities
- Registered Canadian amateur athletic associations
- Canadian municipalities in Charlotte County and rural southwestern New Brunswick
- Her Majesty in right of Canada and the Province of New Brunswick and agents thereof (Federal and Provincial Government and Agencies) eg. Schools

The following types of organizations and activities are **ineligible** for a grant from Fundy Community Foundation:

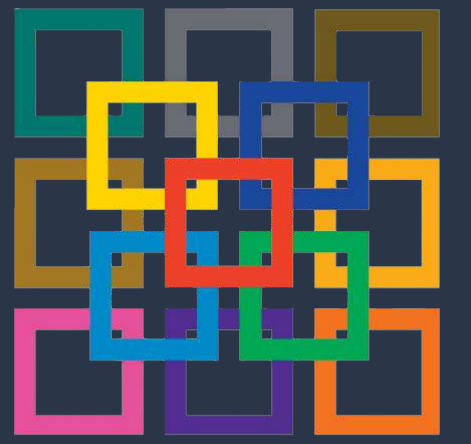
- Non-registered charitable institutions **unless** supported by a qualified organization as described above through a charitable partnership (visit our [website](#) for more information)
- For-profit organizations
- Organizations not located or running programs in Charlotte County or rural southwestern New Brunswick
- Individuals

What types of projects are eligible?

Fundy Community Foundation will consider funding requests from qualified donees that enhance the overall quality of life for those living in rural southwestern New Brunswick. Some examples of eligible projects are (not an exclusive list):

- Summer camps and after-school programs
- Art camps and classes
- Projects designed to protect or restore culture and heritage
- Projects designed to provide essential items to individuals or families in need
- Programs designed to provide outreach to vulnerable populations
- Environment education or awareness programs

Fundy Community Foundation will favor applications that address themselves to:

- Meet the needs of the community in coordination with other local grantmaking bodies
- Address the root causes of problems in the community rather than the symptoms
- Embody the efficient use of community resources
- Involves an innovative and cooperative approach to the challenges facing communities

The Foundation may, in determining which applicants receive funding, give particular attention to the following criteria:

- Seriousness of the need
- Degree of potential benefit to the community served
- Level of cooperation and coordination with other programs in the same field
- Reasonable assurance that the amount the Foundation can grant is sufficient to encourage the results sought

The following types of activities are **ineligible** for a grant from Fundy Community Foundation:

- Activities promoting any particular religious doctrine
 - Political lobbying or campaigns
 - Annual campaigns
 - Retroactive expenses against a project
 - Endowment funds
 - Core operating costs (administrative and/or equipment)
 - Ongoing advertising/marketing of the organization
 - Projects designed for fundraising purposes
 - Profit-generating projects or activities
 - Any activity taking place outside of Charlotte County or rural southwestern New Brunswick
 - Project costs that have received funding through another FCF grant or a grant from another foundation in the same year. A project can receive funding from more than one source as long as there is no duplication of funding for the same project costs.

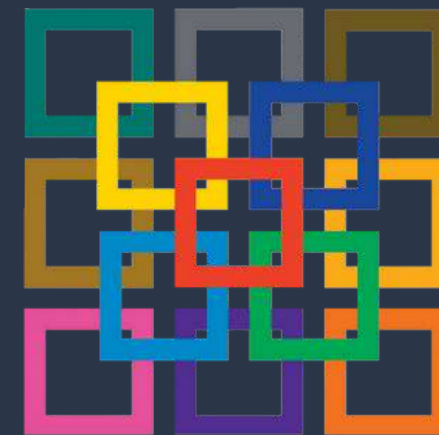
What happens if my application is successful?

Fundy Community Foundation's Grants Committee reviews all applications both individually and as a group. Should the decision be made to support your project, you will receive notification by email with the details of your award.

EFTs will be made to the grantee, and issued within a week of approval. **Note:** if you are non-profit applying using a charitable partner, the EFT will be issued to the partner organization with directions for forwarding the funds.

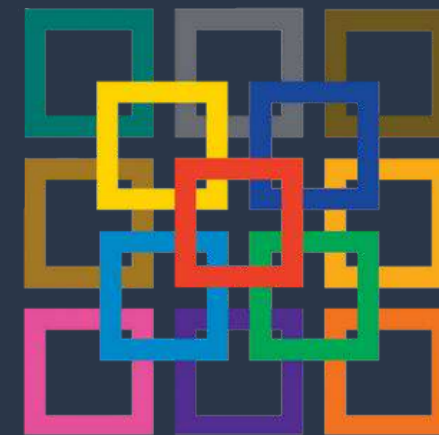

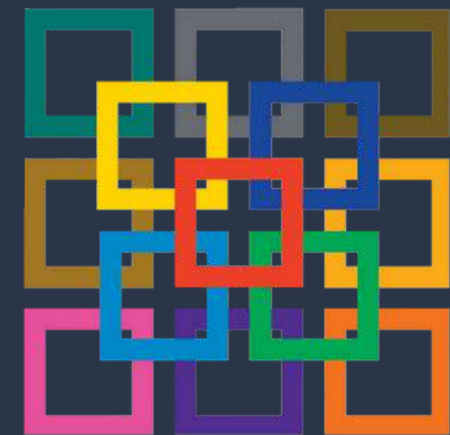
